ORDER

Provisional affiliation was granted for starting self-financing B.Ed. programme at Mar Osthathos Training College (Unaided), Perumpilavu, Kunnankulam, Thrissur during 2005-06 with an intake of 100 students, vide the U.O read as first.

2. NCTE, after adoption of Regulations 2014, given renewed recognition to B. Ed. programme of two-year duration at Mar Osthathos Training College for two basic units of 50 students (ie; 100 students) from 2015-16 academic session, vide paper read as second.

3. As per the University Order read as third, permission was granted to consider the applications received from the training colleges, at the beginning of each academic year (from 2017- 18 onwards) as in the case of other courses and grant Continuation of Provisional Affiliation, without insisting orders for the extension of approval from the NCTE in each year.

4. Vide U.O read as fourth above, revised permanent seat distribution was granted among different optional subjects in the B.Ed programmes at various affiliated training colleges from the academic year 2020-21 onwards .

5. Continuation of Provisional affiliation was granted to the B Ed programme for the academic year 2021-22, vide U.O read as fifth above.

6. The Principal, Mar Osthathos Training College (Unaided), Perumpilavu, Kunnankulam, Thrissur, as per the paper read as sixth, has requested to grant continuation of provisional affiliation to the B.Ed programme for the academic year 2022-23. An amount of ₹1,54,350/- (Rupees one lakh fifty four thousand three hundred and fifty only) has remitted vide chalan No.212541154 dated 15.12.2021 towards administration and affiliation fee.

7. Vide G.O read as seventh, Department of Higher Education, Govt. of Kerala has renewed the NOC for conducting self financing B.Ed Programme at Mar Osthathos Training College (Unaided), Perumpilavu, Kunnankulam, Thrissur for the academic year 2022-23.

8.The Principal has submitted necessary documents along with the application which have been

insisted in the U.O. and Circular read as eighth & ninth respectively.

9. Considering the matter in detail, sanction has been accorded by the Vice Chancellor, on 17.06.2022, for granting Continuation of Provisional Affiliation to the self financing B.Ed programme at Mar Osthathos Training College (Unaided), Perumpilavu, Kunnamkulam, Thrissur for the academic year 2022-23 .

10. Continuation of Provisional Affiliation is, therefore, granted to self-financing B.Ed programme at Mar Osthathos Training College (Unaided), Perumpilavu, Kunnamkulam, Thrissur for the academic year 2022-23 as detailed below, subject to the conditions mentioned hereunder.

11. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

12. In the light of the directions of the Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take stringent measures for prevention of ragging in any form. In case of failure to prevent such instance of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

13. The conduct of University examinations of any sort including that of SDE examinations is compulsory and binding on all colleges affiliated to the University of Calicut.

14. Affiliation granted is strictly provisional and only for the academic year 2022-23 .The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University.

15. The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid affiliation orders.

16. Admission to the next academic year shall be made only after obtaining prior permission from the University.

Orders are issued accordingly.
